Morgan County Human Resources Director Tracy Amen presented to the Board for approval, Resolution 2018 BCC 06, Resolution adopting an Equal Employment Opportunity Plan. Ms. Amen stated this plan outlines the details of how the hiring process will be and that it will be equal opportunity for all. She explained that the plan identifies where all EEO's will be posted which includes all of the County buildings, statements on job descriptions, this will be included on County applications, information will be included in the personnel policy and also to be placed on the County website. Ms. Amen stated that once the new County website is up and running it will be posted in different languages. At this time, Ms. Amen asked for approval of the Equal Employment Opportunity Plan.

Commissioner Teague made a motion to approve Resolution 2018 BCC 06, a resolution adopting an Equal Employment Opportunity Plan as presented by Morgan County Human Resources Director Tracy Amen with Commissioner Zwetzig seconding the motion. At this time, the motion carried 3-0.

## **Consideration of Approval – RIGHT OF WAY - 2018 PMT 02 – Kyle Kembel**

Morgan County Road Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2018 PMT 02, with Kyle Kembel. Mr. Goodman stated this right of way permit is for trenching across County Road V (Segment 900) in two locations, first crossing at a point 1063 feet south of County Road V intersection also identified as the center of the NE1/4 of Section 24, Township 4 North, Range 58 West of the 6<sup>th</sup> PM trenching east/west across County Road V to install a 10 inch irrigation pipe, second crossing at a point 1022 feet West of County Road V intersection also identified as the center of the NE1/4 of Section 24, Township 4 North, Range 58 West of the 6<sup>th</sup> PM trenching north/south across County Road V to install a 15 inch irrigation pipe, for the purpose of installing 10 inch and 15 inch 100# pipe irrigation lines. Commissioner Zwetzig stated that he called Mr. Kembel to revise the distances, they are the points that he would like to cross and they have decided for mapping purposes that have added segment 900 that will now refer to the road segments that are in the HUTF funds and the GIS mapping system. Also, they have asked Mr. Kembel to measure from a closer corner for segment purposes. Commissioner Teague questioned if the amount for the permit is correct with Commissioner Zwetzig stating there is an over payment of \$6.60. Chairman Arndt stated that the County would owe Mr. Kembel \$6.60 making the total amount of the permit as \$250.00.

Commissioner Zwetzig made a motion to approve Right of Way Permit 2018 PMT 02, with Kyle Kembel as outlined in the narrative of the permit noting the fees in the amount of \$250.00 are attached as presented by Morgan County Road Supervisor John Goodman and authorized the Chair to sign noting there will be corrections to the permit. Commissioner Teague seconded the motion. At this time, the motion carried 3-0.

## **Consideration of Approval – BID AWARD – RFP 2018-0118-002 Jackson Lake Water (1) Share**

Morgan County Administrative Services Manager Kristi Waite presented to the Board for approval, the RFP 2018-0118-002 Jackson Lake Water (1) Share. Ms. Waite stated that they received only one bid from Fort Morgan Water Company, Ltd in the amount of \$500.00. Ms. Waite stated Fort Morgan Water Company, Ltd has had this share in the past.

Commissioner Teague made a motion to approve award the RFP 2018-0118-002 Jackson Lake Water (1) Share Bid Award in the amount of \$500.00 to Fort Morgan Water Company, Ltd as recommended by Morgan County Administrative Services Manager Kristi Waite and authorized the Administrative Services Manager to execute the necessary contract to be ratified at a later date. Commissioner Zwetzig seconded the motion and motion carried 3-0.

## **Congressional Update – Darlene Carpio, Regional Director of Senator Cory Gardner Office**

Darlene Carpio, Regional Director of Senator Cory Gardner Office stated she appreciates that she can work with Morgan County. Ms Carpio explained the last time that she presented an update she had been asked about the farm bill and further indicated currently there is an aggressive timeline in which there is information that the bill should make it through the House by April 1<sup>st</sup> and then through the Senate within two to three months after that. She stated with this aggressive timeline it seems that they are not looking at making very many changes. She further stated they are working very hard in trying to educate the Trump administration on trade agreements.

Ms. Carpio stated that health care is still an issue but this will be put on the back burner. Things like immigration, budget and infrastructure are going to be much more of the priority. There have been some white papers with federal infrastructure and what that will look like and they are working with staff about what will be new and different that will be offered to the rural areas.

She stated that locally they are still keeping in communication with Western Sugar, which is a vital asset to the economics in Morgan County. Ms. Carpio explained that she knows there is a lot going on in Morgan County, one being advances in broadband, an increase of construction occurring within the County and would like to know what the Board would like her to take back to discuss with Mr. Gardner. Commissioner Zwetzig stated that Senator Gardner, Representative Buck and other legislative individuals need know that immigration reform is a necessary tool that needs to get done and would like something to be done this year. Ms. Carpio stated that Senator Gardner was a member of the gang of six that put forth some immigration reform proposals, and they will be looking at those again. She further stated one thing that citizens need to be aware of is how dependent we are on a good sound immigration programs in the agricultural world due to so much of that workforce coming from that population, and they are an asset to the community and how do we take all of that into consideration and make that work. Ms. Carpio stated that if the board has any input it would be helpful for her office.

The Board thanked Ms. Carpio for being here today and for the work she does for the Senator.

Ms. Cherry stated that the zoning regulations have been updated on the County website and are the most current; the subdivision regulations are being worked on and will be updated as soon as they are finished.

Chuck Miller, 26060 Morgan County Road S Brush, Colorado stated that he attended the Brush City Council meeting and they will be having a Planning and Zoning Commission meeting for the adoption of the new floodplain,

floodway rules and regulations and the base elevation maps for February 5<sup>th</sup>. He stated he is very vested in this process. The reason he is here today is because these new floodplain, floodway rules and regulations and maps are a tremendous hit and finds it challenging for the newly announced candidate for assessor. He stated that we are looking at a big hit on the tax values and the situation there. He explained that in Brush there is a school bond that seems to be quite over coming at this point they have received their taxes and there has been a lot of discussion and more to come. He stated that everyone knows what the floodplain and floodway rules and regulations do to the footprints and we know what that does to the tax base. The school district is thinking of destroying the junior high complex and the minute it is destroyed, it will fall under a completely new set of rules and regulations due to it being in the new floodway. Mr. Miller feels that there are some real challenges and that the County Commissioners are still looking for ways to mitigate this topic. It looks that Brush is not looking for any ways to changing things and they are going to adopt what they have. He stated it is a serious situation, and we have seen the effects and will continue to see them heavier.
