Some Helpful Hints!

TO AVOID LONG WAITING TIMES IN OUR OFFICE, REMEMBER THE FOLLOWING HINTS!

- THE LAST WORKING DAY OF THE MONTH SEEMS TO BE THE BUSIEST DAY FOR OUR OFFICE, THEREFORE, THE LINES TEND TO BE LONGER AND WAITING TIMES INCREASE GREATLY
- TRY TO AVOID ARRIVING AT THE MOTOR VEHICLE DEPARTMENT RIGHT BEFORE END OF DAY, CLOSING TIME AT 4:00 P.M., THIS ALSO TENDS TO BE A TIME FOR HIGHER VOLUMES OF CUSTOMERS
- HAVE ALL YOUR DOCUMENTS AND INFORMATION READILY AVAILABLE WHEN YOU ARRIVE, IF YOU HAVE NOT OBTAINED THE NECESSARY SIGNATURES AND ARE MISSING PROOF OF INSURANCE, VALID IDENTIFICATION, THIS WILL DELAY YOUR TRANSACTION AND ALSO CAUSES A DELAY FOR OTHERS
- REMEMBER, YOU MAY MAIL YOUR VEHICLE REGISTRATION RENEWAL BY SENDING IT TO THE MORGAN COUNTY CLERK AND RECORDER'S OFFICE WITH THE RENEWAL CARD, AND ENCLOSE YOUR CHECK OR MONEY ORDER TO AVOID HAVING TO WAIT IN LINE WHATSOEVER! IF YOUR RENEWAL CARD STATES YOU ARE TO PROVIDE PROOF OF INSURANCE, PLEASE REMEMBER TO ENCLOSE A COPY OF YOUR CURRENT INSURANCE CARD.
- YOU MAY ALSO RENEW YOUR VEHICLE REGISTRATION ONLINE BY ACCESSING www.colorado.gov/renewplates AND CAN PAY BY CREDIT CARD, (REMEMBER THERE IS A 2.7% FEE FOR USING YOUR CREDIT CARD) IF YOUR RENEWAL CARD STATES YOU MUST PROVIDE PROOF OF INSURANCE, YOU CANNOT RENEW ONLINE. PLEASE CONTACT OUR OFFICE FOR FURTHER INFORMATION.

STATE STATUTE FOR INSURANCE

Pursuant to 42-4-1409, C.R.S., the penalties for failure to have motor vehicle insurance coverage is a Class 1 Misdemeanor Traffic Offense punishable by a mandatory minimum ten days imprisonment, or three hundred dollar fine, or both or a mandatory maximum one year imprisonment, or one thousand dollar fine, or both shall be imposed by section 42-4-1701(3)(II)(A), C.R.S.; and

- A. A minimum mandatory fine of not less than five hundred dollars or greater if imposed by the court; and
- B. At the discretion of the court, not less than forty hours of community service, subject to the provisions of section 18-1.3-507, C.R.S.
- C. A second or subsequent conviction within a period of five years following a prior conviction, a minimum mandatory fine of not less than one thousand dollars.
